#### **Consolidated Revenue declined by 16%**

#### **Q3 FY21**

Kaya Limited posted consolidated Revenue from Operations of INR 87.9 crores for the quarter ended 31<sup>st</sup> December 2020, a decline of 16% over corresponding quarter ended 31<sup>st</sup> December 2019.

India business reported Revenue decline of 25% and International business declined by 5% over Q3 LY

Consolidated Operating EBITDA at INR 18.8 crores for the quarter ended 31<sup>st</sup> December 2020, as compared to INR 17.1 crores for the corresponding quarter in previous year.

Consolidated Profit after Tax and Minority Interest for the quarter ended 31<sup>st</sup> December 2020 is break-even, compared to Loss of INR 21.0 crores for the corresponding quarter ended 31<sup>st</sup> December 2019.
