The voting rights of the Members shall be in proportion to their share of the paid-up equity share capital of the Company as on the Cut-Off Date. 4. In compliance of provision with Section 108 and Section 110 and other applicable provisions of the Act, as amended, read together with the Rule 20 and 22 of Companies (Management and Administration) Rules, 2014 and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (hereinafter referred to as the “SEBI (LODR) Regulations”), Secretarial Standards-2, MCA Circulars and SEBI Circulars, issued time to time, the Company is pleased to offer remote e-voting facility to its the members. The Company has engaged the services of **National Securities Depository Limited (NSDL)** for facilitating e-voting to enable the members to cast their votes electronically (hereinafter referred to as the “Remote e-voting”). In accordance with the MCA Circulars and SEBI Circulars, physical copy of the Notice along with Postal Ballot Form and pre-paid business reply envelope will not be sent to the members for this Postal Ballot. The communication of the assent or dissent of the members would take place through the process of Remote e-voting only.
5. Notice is also placed on the website of the Company i.e. www.kaya.in and the website of NSDL i.e. www.nsdl.co.in and shall also be available on the websites of the stock exchanges on which the shares of the Company are listed i.e. BSE Ltd. (www.bseindia.com) and National Stock Exchange of India Ltd. (www.nseindia.com).
6. The remote e-voting period commences on Tuesday, September 5, 2023 and ends on Wednesday, October 4, 2023. The remote e-voting module shall be disabled for voting thereafter. During this period, the members of the Company holding shares in physical or electronic form, as on the Cut-Off Date may cast their vote by electronic means in the manner and process as mentioned in this Notice. Once the vote on a resolution(s) is cast by the member, the member shall not be allowed to change it subsequently.


7. The board of directors (“Board”) of the Company appointed Mr. Sitansh Magia, (Membership No.: - A15169), Practicing Company Secretary, as a Scrutinizer to scrutinize the postal ballot process in a fair and transparent manner.
8. The Scrutinizer will submit his report to the Chairman or any other person authorised by him after completion of the scrutiny of the e-voting. The Scrutinizer’s decision on the validity of votes cast will be final. The results of the Postal Ballot will be announced by the Chairman of the Company, or any other person authorised by him not later than 2 working days from the conclusion of remote evoting at the registered office of the Company, i.e. on or before October 6, 2023.
9. The result of the Postal Ballot along with the Scrutinizer’s Report will also be placed on the Company’s website www.kaya.in and also on the NSDL’s website www.nsdl.co.in and shall be communicated to the Stock Exchanges where the Company’s shares are listed. The Board of Directors of the Company at its meeting on May 24, 2023 had, in principle, approved the plans to reorganize the Company's business in the Middle East, for which the Company would enter into requisite arrangements with local owners/affiliates through its direct and step-down subsidiaries namely, Kaya Middle East DMCC ("DMCC") and Kaya Middle East FZE ("FZE") (DMCC & FZE are collectively hereinafter referred to as "Kaya GCC Entities"), as the case maybe, subject to the receipt of applicable statutory and regulatory approvals.

As part of the overall reorganization, it was also proposed that the Company would reorganize the ownership rights in the clinics, located in the GCC Countries, by way of

- (i) incorporation of new limited liability company / companies ("LLC"); or
- (ii) acquisition of existing LLC(s) from local owner(s)/affiliates and/or converting the relationship with the local partners/affiliates into joint venture entities, which shall own one or more clinic(s) per LLC; or
- (iii) exiting from the existing arrangement, in view of the formation of the reorganized structure.

In terms of the aforesaid, the Company vide postal ballot notice dated June 14, 2023 has obtained the shareholders' approval for FZE to sell, transfer, or otherwise dispose of its assets to the newly formed/ acquired LLC's.

Now, in furtherance of the aforesaid, DMCC, the material subsidiary of the Company has entered into definitive agreements to sell its entire holding in Minal Medical Centre LLC ("MMC") and M M C Skin Clinic LLC ("MMCSC"), to Dr. Minal Patwardhan, existing partner of DMCC, who currently holds 28.33% each in MMC and in MMCSC, subject to the approval of the shareholders of the Company.

The investments proposed to be transferred by DMCC in MMC & MMCSCS exceed 20% of the total assets of DMCC. In terms of Regulation 24(6) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, selling, disposing of or leasing of assets amounting to more than twenty percent of the assets of the material subsidiary on an aggregate basis during a financial year shall require prior approval of shareholders by way of special resolution, except in cases where such divestment is vide a Court/ National Company Law Tribunal Order. Hence, the Board is required to obtain the consent of the shareholders of the Company by way of a Special Resolution.

Upon completion of the aforesaid transfer of investments, MMC & MMCSC will cease to be the step-down subsidiaries of the Company.

Your Board recommends the Special Resolution set out above in Item No. 1 of the Postal Ballot Notice for approval of the Members. None of the Directors and/or Key Managerial Personnel of the Company or their relatives is in any way concerned or interested in the resolutions detailed in Item No. 1 of the Postal Ballot Notice, except to the extent of their shareholding, if any, in the Company.
